

RESOLUTION NO 91-17

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY AUTHORIZING AND DIRECTING THAT ALL MEMBERS/APPOINTEES OF THE SHERIFF'S OFFICE OF ST. JOHNS COUNTY, FLORIDA WHO ARE ELIGIBLE UNDER FLORIDA STATUTE CHAPTER 115, FLORIDA STATUTE 121.111, AND/OR 1991 HOUSE BILL 15-B FOR DISCRETIONARY AND/OR SUPPLEMENTAL PAY AND/OR BENEFITS SHALL, AT ALL TIMES SUBSEQUENT TO JULY 31, 1990 AND UNTIL THIS RESOLUTION IS RESCINDED OR MODIFIED, RECEIVE ALL DISCRETIONARY AND/OR SUPPLEMENTAL PAY AND BENEFITS AUTHORIZED BY THOSE LAWS.

WHEREAS, members/appointees of the Sheriff's Office of St. Johns County have been, or are anticipated to be, called to active military service because of the current conflict with Iraq; and

WHEREAS, Florida Statute Chapter 115, Florida Statute 121.111 and/or 1991 House Bill 15-B authorize the Sheriff as employer and in his discretion to grant leaves of absence, supplemental pay, continue health insurance, and other existing benefits, and make employer retirement contributions to or for those of his members/appointees who are eligible under such laws and are called to active military service; and

WHEREAS, the Sheriff of St. Johns County finds that it is in the best interests of the County to implement the full discretionary provisions of such laws;

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida as follows:

Section 1. All members/appointees of the Sheriff's Office of St. Johns County, Florida who are eligible under Florida Statute Chapter 115, Florida Statute 121.111 and/or 1991 House Bill 15-B for the discretionary leaves of absences, supplemental pay, continued health insurance and other existing benefits and/or employer retirement contributions authorized by such laws to be granted or paid to or for such members/appointees shall, at all times subsequent to July 31, 1990 and until this resolution is rescinded or modified, be granted such leaves of absences, supplemental pay, continued health insurance and other existing benefits, and employer retirement contributions in the manner and as authorized by those laws.

Section 2. It is recognized that house bill 15-B may not, as of the date of this resolution, have become law. Nevertheless, it is the intent of this resolution that the references herein to House Bill 15-B shall apply immediately upon such bill becoming law.
