Hearing on R-88-018; Mar-Wayne Associates and Andrew Sperlanes, located on U.S. #1 South, Scott Honda, change in existing conditional ordinance to allow fence to be located on property line instead of inset from property line. Proof of publication of notice of intent to consider an ordinance was received having been published in The St. Augustine Record on July 28, 1988; upon motion by Brubaker, seconded by Waldron, carried 5/0, was ordered filed. Report of the Planning & Zoning Agency recommending approval was received. Attorney John Bailey, Jr. representing the applicant was present requesting approval. Attorney Bailey submitted into the record photos of the fence in question and indicated all other conditions will remain the same. (4.0880) Rosemary MacWilliams, 5419 Shore Drive spoke in favor of this request. Motion by Bailey, seconded by Brubaker, carried 5/0, adopting Conditional Ordinance No. 88-50.
