Hearing on Major Modification to Planned Special Development, R-PSD87-057 Lewis Point Plaza, request change in use of portion of property and an additional entrance off U.S. #1. Proof of publication of notice of hearing was received, having been published in The St. Augustine Record on November 23, 1990; motion by Bailey, seconded by Brinkhoff, carried 7/0, was ordered filed. Napier requested this item be continued to February 26, 1991 at 1:45 p.m.; It was the general consensus of the Board to reschedule R-PSD87-057 Lewis Point Plaza till February 26, 1991 at 1:45 p.m..

Commission Reports continued: Bailey presented a packet consisting of a resolution from Duval and Clay Counties opposing the cogeneration plant on the Northside of Jacksonville known as The Cedar Bay Cogeneration Project; Bailey outlined the existing and projected problems due to this; Bailey further stated that Clay and Nassau Counties along with the City Council of Jacksonville has drafted resolution of opposition to oppose the permitting by DER and requested the St. Johns County Commissioners do the same in the form of a similar resolution; DER will be having a regular hearing with the Governor and cabinet on January 22, 1991; It was the consensus of the Board to support this efforts; Upon motion by Maguire, seconded by Bailey, carried 7/0 to direct staff to draw up a resolution identical to the one put out by Clay County authorizing the Chairman of the Board to sign said resolution. The resolution is to be mailed to the Governor and Cabinet DNR with a copy to the City Council of Jacksonville, Resolution No. 91-07.
