**ORDER GRANTING TEMPORARY
USE PERMIT**

The above-referenced applicant requested a Temporary Use Permit under the St. Johns County Zoning Ordinance to allow sidewalk sales/for fund raising projects on the following dates: July 17, 1993 or July 24, 1993; October 16, 1993 or October 23, 1993; November 13, 1993 or November 20, 1993; and December 4, 1993 or December 11, 1993 at the present location of Wal-Mart Shopping Center. Since the TUP is for four weeks or less, it was not reviewed by the Planning and Zoning Agency.

**FINDINGS OF FACT
AND ORDER**

Having considered the application and supporting documents; the applicant's statements at the July 13, , 1993, Board of County Commissioners meeting; and the comments of staff at the July 13 , 1993 hearing; the Board of County Commissioners makes the following findings of fact:

1. TUP-93-002 has been fully considered after public hearing pursuant to legal notice duly published as required by Section 10-12 of the St. Johns County Zoning Ordinance;
2. The request is consistent with the requirements of Section 10-12 of the St. Johns County Zoning Ordinance, and is not inconsistent with the Comprehensive Plan;
3. Planning Department staff report that they have no objection to approval of the TUP, provided that the outdoor promotion/ sales projects do not create traffic or parking problems or a fire hazard;

NOW THEREFORE, the Board of County Commissioners hereby grants temporary use permit, TUP-93-002 as follows:

The application for Temporary Use Permit for outside sales/promotion fund raising events from Civitan Club of St. Augustine and Flagler College Campus Civitan Club to begin on July 17, 1993; October 16, 1993; November 13, 1993 and December 4, 1993 OR THE ALTERNATE DATES OF July 24, 1993; October 23, 1993; November 20, 1993 and December 11, 1993, at the Wal-Mart PLAZA, LOCATED ON U.S.#1 South, , St. Augustine, Florida as described herein is hereby granted. The applicants shall conduct the outdoor/fund raising events in such a manner as not to obstruct vehicular or pedestrian flow and shall not create a fire hazard .
