**ORDER GRANTING TEMPORARY
USE PERMIT**

The above-referenced applicant requested a Temporary Use Permit under the St. Johns County Zoning Ordinance to allow fund raising event consisting of a car show and evening performers to be held at the St. Johns County Motorsports Complex located on Big Oak Road on one of the following dates:

OCTOBER 17; OCTOBER 24; or NOVEMBER 7
1993

Since the TUP is for four weeks or less, it was not reviewed by the Planning and Zoning Agency.

**FINDINGS OF FACT
AND ORDER**

Having considered the application and supporting documents; the applicant's statements at the September 28, 1993, Board of County Commissioners meeting; and the comments of staff at the September 28, 1993 hearing; the Board of County Commissioners makes the following findings of fact:

1. TUP-93-006 has been fully considered after public hearing pursuant to legal notice duly published as required by Section 10-12 of the St. Johns County Zoning Ordinance;

2. The request is consistent with the requirements of Section 10-12 of the St. Johns County Zoning Ordinance, and is not inconsistent with the Comprehensive Plan;
3. Planning Department staff report that they have no objection to approval of the TUP, provided that the event complies with the conditions of the current zoning exception for racetrack on the same property.
4. The charitable, non-profit status, of the applicant supports its request for waiver of applicable fees.

NOW THEREFORE, the Board of County Commissioners hereby grants temporary use permit, TUP-93-006 as follows:

The application for Temporary Use Permit for an outdoor car show in the afternoon and performers in the evening for fund raising event as described herein to be located at St. Johns County Motorsports Complex, Big Oak Road, St. Augustine, Florida is hereby granted, St. Johns County Application Fees of \$150.00 is hereby waived.. The applicants shall conduct the fund raising event in compliance with Order of the Planning and Zoning Agency granting racetrack for vehicles on the same property. .
