(8:08 a.m.) McCormack noted that the State had extended the permitting for bulkhead construction on the beach and questioned the amount of participation regarding permits. Locklear stated that there had been 21 permits issued that were actively working on bulkhead construction. Discussion ensued on a timeline for debris pick-up and

communication with residents. Locklear noted that the County did not pick-up debris on State roads.
